General Release Statement

I do hereby give Matthew A. Kieffer (the Photographer), his or her assigns, licensees, successors in interest, legal representatives, and heirs the irrevocable right to use my name (or any fictional name), picture, portrait, or photograph in all forms and in all media and in all manners, without any restriction as to changes or alterations (including but not limited to composite or distorted representations or derivative works made in any medium) for advertising, trade, promotion, exhibition, or any other lawful purposes, and I waive any right to inspect or approve the photograph(s) or finished version(s) incorporating the photograph(s).

I agree that the Photographer owns the copyright in the photographs taken and I hereby waive any claims I may have based on any usage of the photographs or works derived there from, including but not limited to claims for either invasion of privacy or libel. I agree that this release shall be binding on me, my legal representatives, heirs, and assigns. I have read this release and am fully familiar with its contents.

Terms and Conditions

1. Photographic Materials. All photographic materials, including but not limited to negatives, transparencies, proofs, and previews, shall be the exclusive property of the Photographer. The Photographer shall make proofs (print or digital) and previews available to the Client for the purpose of selecting photographs. The Photographer may make the proofs available on a Web site or Digital Media, such as a CD. The Client understands that pictures displayed on the Photographer's website are open to the public. The photographer may also use the photos in other venues, such as art shows, websites, and other points of interest, for the purpose of promoting and sharing his work.

2. Copyright and Reproductions. The Photographer shall own the copyright in all images created and shall have the exclusive right to make reproductions. The Photographer may also use the images for promotional purposes; however, a separate contract is required for the sale of reproductions, in both print and digital formats.

3. Client's Usage. The Client is obtaining prints for personal use only, and shall not sell said prints or authorize any reproductions thereof by parties other than the Photographer, or the Photographers approved printing agents. If the Client is obtaining a print for newspaper announcement of the wedding, the Photographer authorizes Client to reproduce the print in this manner. The photographer also gives the Client permission to make home copies up to 11 inches at the width or length, and mini lab reproductions of 4"x6" and 5x7". The photographer will charge \$20 (subject to change bi-annually) for a release to a lab. The photographer is not responsible for any prints not purchased through him.

4. Inherent Qualities. The Client is aware that color dyes in photography may fade or discolor over time due to the inherent qualities of dyes, and the Client releases the Photographer from any liability for any claims whatsoever based upon fading or discoloration due to such inherent qualities. Due to the fading of negatives, and the nature of digital media being corruptible or becoming un-retrievable, the Client understands that they have 2 years to purchase prints, and after 2 years the Photographer is no longer responsible for safeguarding the negatives or digital files.
